

City of Branson West

An Ordinance amending the sewer service rates ordinances of the City by adding a new subsection D to Section 710.230 for rates for dumping of wastewater by tank truck and renumbering subsection D to as subsection E.

The Board of Aldermen of the City of Branson West, after holding a public hearing on April 9, 2024, after notice of the hearing was published in the Crane Chronicle Stone County Republican on March 7, 2024, at least 30 days in advance of April 9, 2024, as required by section 250.233 RSMo, hereby adopts an ordinance to amend sewer rates, as follows:

Section 1.

D. The rates for customers who deliver wastewater by truck to the City’s wastewater treatment system shall be charged per delivery as follows, regardless of the actual quantity of wastewater delivered into the City’s wastewater treatment system, to be billed by the City based on observed numbers of deliveries:

Size of Tank Delivering Wastewater in Gallons	Rate per delivery
2,500 to 3,500	\$42.00
3,501 to 4,000	\$48.00
4,501 to 5,000	\$60.00
5,001 to 6,000	\$72.00
6,001 to 6,500	\$78.00
6,500 to 7,000	\$84.00

E. The monthly sewer rates stated in the preceding Subsection C shall be doubled for each connection to a dwelling or other structure located entirely outside the City limits (regardless of whether any part of the parcel on which the dwelling or other structure is located partially inside the City limits).

Section 2. This ordinance shall be effective with the May 2024 billing cycle, so that proration is not required.
